**CURRENT BILLS:** Trustee Kolling moved, and Trustee Rojas seconded the motion to accept the current bills as presented. Upon roll being called all Trustees present voted "Aye." President declared said motion carried.

**PETITION & COMMUNICATION:** Sally Gray came before the Board to invite Board Members and the public to the Tourism Event. The event takes place on Sunday, August 27<sup>th</sup> starting at 11am at the Campus. **STREET DEPT:** Trustee Higley moved, and Trustee Kolling seconded the motion to approve the Sunset Main Change Order from 8 inch to 10 inch with an updated total cost of \$126,391.00. A brief discussion ensued about why this is necessary. Upon roll being called all Trustees present voted "Aye." President declared said motion carried.

Trustee Higley moved, and Trustee Kolling seconded the motion to approve the proposal for professional design services from Fehr Graham for the McKendrie Avenue Reconstruction design with half the contract price paid in the current fiscal year 2023, and the remaining contract price to be paid in the next fiscal year 2024. There was discussion about this project relating to the location of the New Fire Department and its impact. Upon roll being called all Trustees present voted "Aye." President declared said motion carried.

Discussion ensued regarding surrounding property being within the Village Upon roll being called all Trustees present voted "Aye." President declared said motion carried.
