**ADMINISTRATION:** President Labash addressed the Board and public regarding the recent fire uptown. The Village is working diligently with our legal team, property owners, and code enforcement to ensure we are operating within our legal limits as well as protecting public safety.

President Labash read the Motorcycle Awareness Proclamation. Trustee Rojas moved, and Trustee Hopkins seconded the motion to declare the month of May Motorcycle Awareness Month in the Village of Mt. Morris. Upon roll being called all Trustees present voted "Aye." President declared said motion carried.

**STREET DEPT:** Trustee Higley moved, and Trustee Rojas seconded the motion to approve reimbursement to Bryan Immel in the amount of \$2000.00 for his CDL course with a conditional 1-year retention agreement with the Village. Upon roll being called all Trustees present voted "Aye." President declared said motion carried.

Trustee Higley reports he received a second opinion on the compression of the blacktop on Sunset. He advised Willett and Hofmann to proceed with the sealing of the street. The terraces should be filled and seeded in the next few weeks.
